**NOTES:**

- In the Poultry/Ratite column, Australia and New Zealand are eligible for export of ratites only.
- Raw pork from Mexico permitted only from States of Baja California, Baja California Sur, Campeche, Chihuahua, Nayarit, Quintana Roo, Sinaloa, Sonora, and Yucatán.
- Raw poultry from Mexico permitted only from TIF 241 and TIF 344 if origin of poultry was U.S. or other END-free country eligible for export of raw poultry to U.S.
- Due to APHIS restrictions, Japan is only eligible to export boneless cuts of beef to the U.S.
- Raw pork from Brazil permitted only from State of Santa Catarina establishments SIF 140, SIF 490, SIF 2183, SIF 3237, SIF 3392, and SIF 3548
